- 1. Elafon Mechanical is currently investigating the most economical and efficient way to remove the asbestos insulation prior to changing the basement hot water pipes. The agent will work with Alan and Elafon to identify the appropriate trade to use to remove the insulation.
- 2. All restaurants in the Retail Section are now off of common hot water.
- 3. A quote has been received to continue upgrades to the Commercial side of the DDC system. After a lengthy discussion this item was tabled until next month when Elafon will be invited to attend the meeting to discuss this item.
- 4. There has been various cleaning, greasing of fans, tightening of belts in fans rooms in the Commercial section.
- 5. One of the floats in the sump failed and as a result the high water alarm sounded. The float has been replaced. Elafon is arranging for Control Solutions to come in and look into setting up an alarm other than just the audible one outside the Titanic room. As this is a strata item, Gordon Forest from the strata council will work with Elafon to identify the best repair/approach to fixing this issue.

6. The landscaping has been mostly completed with the landscaping committee will have a walkthrough with the landscaper to address any finial issues before approving final payment(s).
